Dehradun-248197, Uttarakhand" with 60 seats in UG (BAMS) course for the academic session 2020-21 under section 13A/13C of the IMCC Act, 1970 and in compliance of order made by the Hon'ble High Court of Uttarakhand at Nainital in WPSB No. 47 of 2021 dated 21/01/2021 - reg.

Sir/Madam,

I am directed to refer to the Ministry's letter No. L.14014/10/2019-EP-1 dated 15.06.2019 related to admission matter for the academic year 2019-20, intimating certain requirements to be fulfilled by the college for consideration of permission for the academic session 2020-21.

- 2. Further, refer to the CCIM's letter No.Ref.03-04/2020-Ay.(103) dated 15.12.2020 forwarding therewith recommendation of the college to the Central Government based on thorough examination of the visitation report Part-I, indemnity bond, affidavit & latest details of teaching, non-teaching and hospital staff submitted by the college along with the assessment report, as the physical verification by conduction of inspection could not be carried out in view of present COVID-19 pandemic situation for the A.Y. 2020-21. The CCIM had recommended to Government of India for not granting permission for UG (BAMS) course due to shortcoming in teaching staff for the academic session 2020-21.
- 3. On examining the case in light of above notified & approved criteria and on perusal of assessment report, it was observed that the college was not fulfilling the basic eligibility condition and the following deficiencies were found:
  - 1. There is 01HF in Kayachikitsa Dept. against the requirement of 02 as per RMS, 2016.
  - 2. There is no HF (P/R) in Ayurved Samhita & Siddhant, Agad Tantra avum Vidhi Vaidyaka and Panchakarma against the requirement of 01 in each departments as per RMS, 2016.



- 3. There is no LF in Rognidan avum Vikriti Vigyan and Kaumarbhritya against the requirement of 01 in each departments as per RMS, 2016.
- 4. 01 Laboratory Technician in Roga Nidan available against the requirement of 02 in Non-Teaching staff as per RMS, 2016.
- 5. College website <u>www.dimsdehradun.com</u> is not available as per sub-regulation 2(f,g h,l and m) of regulation 9 of RMS, 2016.
- 4. In view of the above shortcomings, under provisions of the first proviso to sub-section (5) of Section 13A of the IMCC Act, 1970, an opportunity of hearing was granted to the college on 13.01.2021 to present the case through virtual mode. Shortcomings communicated to the college, submission made by the college and the observations of hearing committee based on the submission made by the college during hearing are as under:

### **Observation of the Hearing Committee**

College representatives has submitted in their submission that Dr. Rajesh Tayade (AYKC02497) is working as a higher faculty in Kayachikitsa Department and they submitted an affidavit regarding arrangement of 01 more HF in KC Department before starting of the session 2020-21. They submitted documents of Dr. Rajesh Tayade (AYKC02497) such as Appointment letter, Joining letter, Promotion letter, Flat allotment letter, office order copies by Principal, attendance (Manual & biometric), Salary slip, Educational certificate and scan copy of central registration application and also submitted affidavit for one more H/F in KC Dept.

As per the documents submitted by the college representatives, it is observed by the hearing committee that Dr. Rajesh Tayade (AYKC02497) has considered as a regular higher faculty (Reader) in Department of K.C. by CCIM in their revised status Assessment letter and regarding to another higher faculty in Dept. of KC, the college accepted that there is not available and recruitment is under process. So there is only 01 H/F in Dept. of KC against the requirement of 02 as per RMS, 2016.

As per observation of hearing committee that the college has only 01 H/F in Dept. of Kayachikitsa against the requirement of 02 as per RMS, 2016.

In this regard it is pertinent to mention that 15 HF in 14 departments for upto 60 UG seats are required as per RMS, 2016. However, for conditional permission 12 HF in 11 departments are required. Whereas, 11 HF in 11 departments are available.

#### Thus, does not fulfil this criterion.

College representatives has submitted in their submission that Dr. Kishore Tarar (AYSS00829) is working as a higher faculty in Ayurved Samhita & Siddhant Department; Dr.Ashwini Kumar Sharma (AYAT00369) in Agad Tantra evam Vidhi Vaidyeka Department and they submitted an affidavit regarding arrangement of 01 more HF (Dr. Paresh Ashok Katariya AYPK00317) in Panchkarma Department before starting of the session 2020-21. In part-I, College has mentioned that there are 02 Lecturer and one higher faculty in the same department.
- ii. Dr. Ashwini Kumar Sharma (AYAT00369) has considered as on paper higher faculty (Professor) in Department of Agad Tantra evam Vidhi Vaidyeka by CCIM in their revised status Assessment letter and the matter is under process **So hearing committee** has not considered as a faculty. However, he has joined as a Professor in department of Ayurved Samhita on dated 01.01.2019 and he also applied for central registration on

- dated 15.01.2020. In part-I, College has mentioned that there are 01 Lecturer and one higher faculty in the same department.
- iii. Regarding to higher faculty in the department of Panchkarma the college accepted that there is not available and recruitment is under process. So there is not available higher faculty in Deptt. of Panchkarma against the requirement of 01 as per RMS, 2016.

# **Observation of the Hearing Committee**

College representatives have submitted in their submission that Dr. Shrikant Randive (AYKC00778) is working as a lower faculty in Rognidan avum Vikriti Vigyan Department and Dr. Satapal Sawant (AYKB00427) in Kaumarbhritya Department. They submitted documents of Dr. Shrikant Randive (AYKC00778) such as Appointment letter, Joining letter, Flat allotment letter, Promotion letter, Time table, Exam duty roaster, notice, University letter, attendance (Manual & biometric), Salary slip, Educational certificate, camp documents, online classes documents, CCIM letter and scan copy of central registration application and documents of Dr. Satapal Sawant (AYKB00427) such as Appointment letter, Joining letter, Flat allotment letter, Time table, Exam duty roaster, notice, University letter, attendance (Manual & biometric), Salary slip, Educational certificate, camp documents, online classes documents, CCIM letter and scan copy of central registration application.

As per the documents submitted by the college representatives, it is observed by the hearing committee that

i. Dr. Shrikant Randive (AYKC00778) has considered as **on paper** lower faculty (Lecturer) in Department of Rognidan avum Vikriti Vigyan by CCIM in their revised status Assessment letter and the matter is under process **So hearing committee has not considered as a faculty.** However, he has joined as a lecturer in department of Rognidan avum Vikriti Vigyan on dated 01.10.2017 and he also applied for central registration on dated 23.11.2019. In part-I, College has mentioned that there are 01 Lecturer and one higher faculty in the same department.

ii. Dr. Satapal Sawant (AYKB00427) has considered as on paper higher faculty (Professor) in Department of Kaumarbhritya by CCIM in their revised status Assessment letter and the matter is under process **So hearing committee has not considered as a faculty.** However, he has joined as a lecturer in department of Kaumarbhritya on dated 02.01.2017 and he also applied for central registration on dated 03.01.2019. In part-I, College has mentioned that there are 01 Lecturer and one higher faculty in the same department.

#### Remark

As per observation of hearing committee that the lower faculty in Department of Rognidan avum Vikriti Vigyan and Kaumarbhritya not considered by CCIM as a 10<sup>th</sup> board meeting. So hearing committee has not considered as a lower faculty in two departments. In this regard it is pertinent to mention that 30 teachers for upto 60 UG seats required as per RMS, 2016. However, for conditional permission 27 teachers are required, whereas, 24 eligible teachers are available.

#### Thus, does not fulfil this criterion.

They submitted documents of Mr. Rajdev such as Appointment letter, Joining letter, registration, attendance (Manual & biometric), Salary slip and Educational certificate and documents of Ms. Nisha such as Appointment letter, Joining letter, Aadhar, Registration, attendance (Manual & biometric), Salary slip and Educational certificate.

As per the documents submitted by the college representatives, it is observed by the hearing committee that

- i. Mr. Rajdev is working as a lab technician in Rognidhan Department and he joined on dated 01.10.2019.
- ii. Ms. Nisha is working as a lab technician in Rognidhan Department and he joined on dated 08.02.2019.

#### Remark

As per observation of hearing committee that 02 Laboratory Technician in Roga Nidan available against the requirement of 02 in Non-Teaching staff as per RMS, 2016.

In this regard it is pertinent to mention that 25 Technical and other staff are required as per RMS, 2016. Whereas, 25 available after considering the observation of hearing committee regarding Lab. Technician. Thus fulfil this criterion.

#### Overall observations -

- i. There is 01 H/F in Kayachikitsa Dept. against the requirement of 02 as per RMS, 2016.
- ii. There is no HF (P/R) in Department of Panchakarma against the requirement of 01 in each department as per RMS, 2016. The matter of higher faculty in Department of Ayurved Samhita &Siddhant and Agad Tantra avum Vidhi Vaidyaka have under CCIM as a 10<sup>th</sup> board meeting. So hearing committee has not considered as a higher faculty in two departments.
- iii. The matter of lower faculty in Department of Rognidan avum Vikriti Vigyan and Kaumarbhritya have under CCIM as a 10<sup>th</sup> board meeting. So hearing committee has not considered as a lower faculty in two departments.
- iv. 02 Laboratory Technician in Roga Nidan available against the requirement of 02 in Non-Teaching staff as per RMS, 2016.
- v. College website <a href="www.dimsdehradun.com">www.dimsdehradun.com</a> is updated as per sub-regulation 2(f,g,h,l and m) of regulation 9 of RMS, 2016.
- 5. On examination of the observations of hearing committee based on submission made by the college representatives during hearing, CCIM recommendations & assessment report dated 15.12.2020 and revised status of Teachers dated 04.01.2021, it is found that the college is **NOT** fulfilling following shortcomings:
  - i. There is 01HF in Kayachikitsa Dept. against the requirement of 02 as per RMS, 2016.
  - ii. There is no HF(P/R) in Ayurved Samhita & Siddhant, Agad Tantra avum Vidhi Vaidyaka and Panchakarma against the requirement of 01 in each departments as per RMS, 2016.
  - iii. There is no LF in Rognidan avum Vikriti Vigyan and Kaumarbhritya against the requirement of 01 in each department as per RMS, 2016.

The Teaching faculty is required to be certified by CCIM as per IMCC, MSR Regulation 2016 clause 3 (1) (f), however, the following 04 teachers are not certified by CCIM as well as not considered eligible by the hearing committee. Thus doesn't fulfill the criteria for Teaching faculty/Higher faculty/Lower faculty:

- 6. The above mentioned 04 teachers filed a court case bearing WPSB No. 47 of 2021 before the Hon'ble High Court of Uttarakhand, at Nanital and a stay order dated 21.01.2021 was issued by the Court. In compliance of the Court order dated 21/01/2021, the CCIM vide its letter dated 12.02.2021, also withheld the letter dated 14/01/2021, issued in respect of these teachers for withdrawal of their teachers code, subject to final outcome of the Writ Petition.
- 7. Since, the deficiency pertains only in respect of teaching staff, therefore, considering the Interim Order of Hon'ble High Court dated 21/01/2021, and CCIM's letter dated 12/02/2021, it has been decided by the Central Government to grant Conditional Permission to Doon Institute of Medical Sciences, (Faculty of Ayurveda) Village Shankarpur, Shahaspur, Teh Vikas Nagar, Distt. Dehradun-248197, Uttarakhand for conducting 60 seats in UG (BAMS) course for the academic session 2020-21 under Section 13C/13A of the IMCC Act, 1970, subject to result of the Writ Petition. The college is directed to inform the students that the permission to admit students has been granted subject to the result of the Writ Petition No. 47/2021(S/B) pending before Hon'ble High Court of Uttarakhand. Further, an undertaking from the students may also be taken that their admission are subject to the result of Writ Petition. The permission to the college is also subject to the following:
  - i. The fulfillment of conditions as specified in the Undertaking/Indemnity bond submitted by the college.
  - ii. The college shall submit an undertaking in form of affidavit duly notarized within one month explaining the details of providing EPF and ESI facilities to the teaching, non-teaching staff of the Colleges/Hospitals and regularly paying the same as per the provisions of Employees' Provident Funds and Miscellaneous Provident Act, 1952 & ESI Act, 1948 and relevant Rules and Regulations
- 8. It is further informed that minimum of 15% of undergraduate of the permitted intake capacity of 60 UG seats shall be treated as all India quota. The counseling for seats under all India quota shall be conducted by respective counseling authority of State/UT Government as designated by Central Government vide letter F.No.L.11011/02/2020-EP (1) dated 26.10.2020 for A.Y. 2020-21 and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned Counseling Authority of that State/UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government for all India quota or the students admitted thereunder.

- 9. Admissions made in violation of the above conditions will be treated as invalid and action will be initiated under IMCC Act & Regulations made thereunder.
- 10. Discrepancies, if any, may be immediately brought to the notice of Board of Governors, CCIM and the Central Government.
- 11. The following requirements should be fulfilled by the college by 31<sup>st</sup> December, 2020 to get permission for the session 2021-22:
  - (i) all the Requirements of Minimum Standard of infrastructure and teaching & training facilities as specified in Regulation 3 of the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016;
  - (ii) all the requirements of the Indian Medicine Central Council (Minimum Standards of Education in Indian Medicine) Amendment Regulations, 2016 (for Ayurveda)
  - (iii) all the requirements under the provisions of the IMCC Act, 1970 and relevant Regulations made thereunder should be fulfilled *in toto*;
- 12. The fulfillment of the conditions given above may be made within the time period specified and compliance report should be submitted by the college to CCIM under intimation to this Ministry. The CCIM will verify that the conditions have been fulfilled by means of an inspection and submit a report along with its assessment in this matter to the Ministry of AYUSH for considering the permission matter from the academic session 2021-22.
